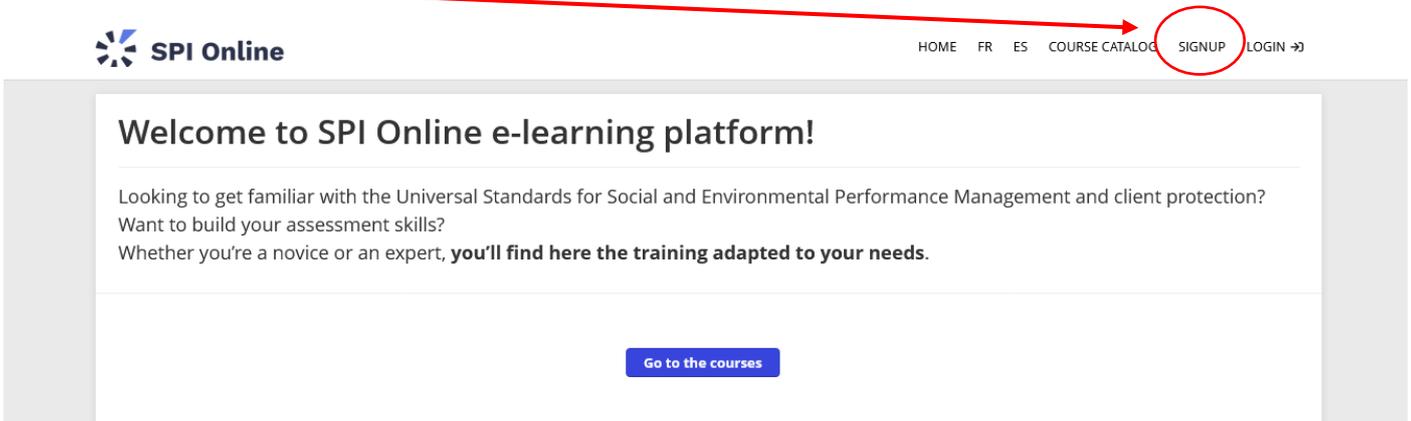


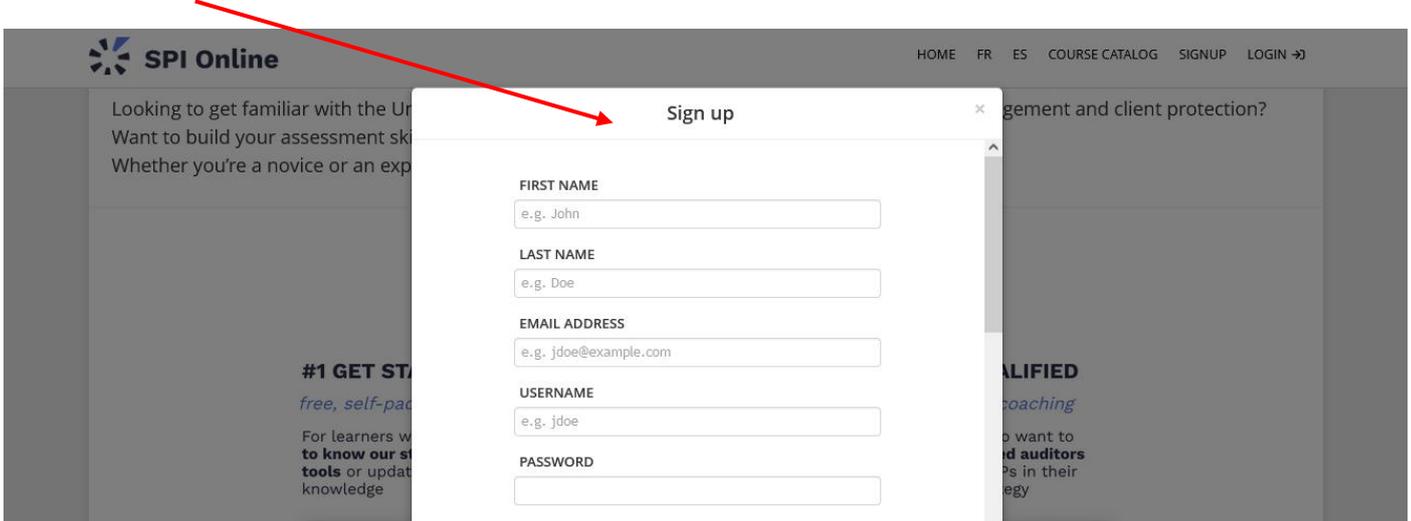

1) Go to SPI Online eLearning Portal: <https://elearning.spi-online.org/>

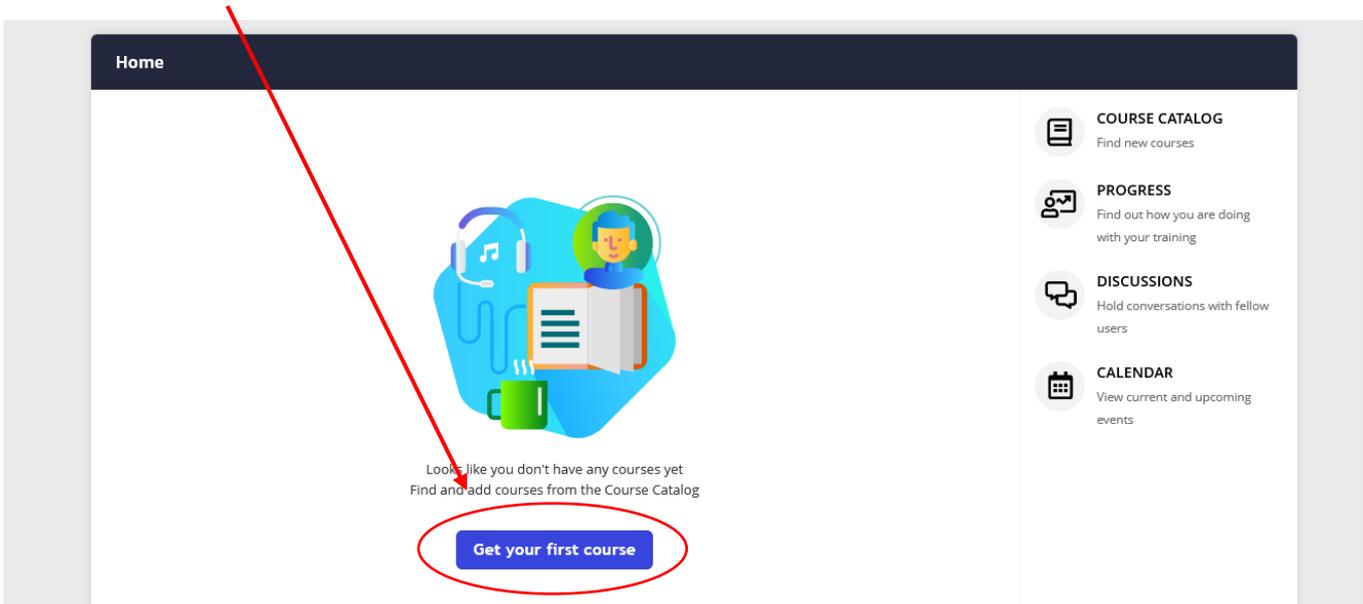
2) At the top right, click on **Sign Up** to create your account.
